

Meeting minutes

Daily Management Group Meeting

14 March 2023

1. INTERACT 3 reporting

The second periodic report could not be submitted on time (28th of February), due to the ongoing amendment to terminate the contract with the Russian partners (see below). As this has now been resolved we expect to submit the second periodic report today or tomorrow.

2. Ongoing amendment – termination of the contract with Russian partners

This amendment was submitted already before the General Assembly in September 2022 but since this is a first time ever situation with the war in Ukraine, it has taken some time for the EU to figure out how to handle everything. The amendment was finally approved last Friday.

3. Future Amendment

When the second periodic report has been approved, we will request another amendment to ask for a one-year prolongation of the project. In addition, we will cease the opportunity to make minor adjustments of a few deadlines for milestones and deliverables and to include the Access Pool transfers, that took place for TA call for summer season 2023, in the budget.

4. TA pool

With the second periodic report we have an update on how much TA money that has been used and how much is left for each partner, so that unused funds can be transferred to those stations in need of more days (due to higher demand). The stations have been informed about the budget transfers and formal letters from the coordinator have been sent regarding the budget transfers to make sure that there is a formal record of the transfer (as the transfers have not been included in an amendment yet).

5. INPA

The current focus for INPA is the upcoming General Assembly that will be held 10 May 2023, at Sauntehus in Denmark. Regarding the voting for Members of the Board, we will ask Caro to take care about this process so that Terry don't have to do it this year as well.

Regarding Arctic Passion, the equipment is on its way to the stations. Caro is currently preparing how to promote this both at INPA and Arctic Passion web sites.



The first eRImote expert group is initiated by Hannele and Vanessa and the first meeting will be held on the 3rd of May.

INPA is a partner in two infrastructure proposals submitted to the EU: POLARIN and AQUARIUS where INPA is offering INTERACCESS as a platform to handle Transnational Access from the Application to the Evaluation to the Reporting stage.

We are currently exploring ways to employ Vanessa in INPA, especially to work with eRImote which she is already involved in.

6. ASSW – conclusions

The book stand had a good location and Vanessa and Hannele handed out all the books and merchandises. The TA user group had good speakers and panel discussions regarding the future of transnational access. Vanessa is now compiling the notes and will cut separate short videos about the presentations and the panel discussions and put them on the INTERACT YouTube channel. This could also be used for eRImote.

There were ICARP IV meetings at the ASSW as well. Henry Burgess is keen on getting input from INTERACTers. Kirsi and Margareta are both involved in ICARP IV. Station Managers and TA users could join in and benefit from this process.

7. New Observer Station – COAT Varanger

There is an application from a research station called COAT in northernmost Norway to become a new observer station in INTERACT. They fulfill the criteria for becoming an observer station and hence the DMG decided to welcome the COAT Varanger station in the network as a new Observer Station.

During discussions on including information from new observer stations on the INTERACT web site, it was concluded that it should now be possible to harvest data from INTERACT GIS to the website to ensure that station managers only have to enter data once.

General Assembly

INTERACT/INPA

Keywords and hashtag should specify whether it is an INTERACT or INPA post.
