The eRImote project (European Research Infrastructures - Pathway to Improved Resilience through Digital and Remote Access) aims to identify **strategies and solutions to enable the transition to more remote and digital access to Research Infrastructure (RI) services** across ESFRI domains. WP3 "Remote Access Landscape Analysis" is responsible for **collecting and analysing** data on the current status and challenges of remote/digital access to Research infrastructure Services. The eRimote project team has therefore created five Expert Groups dedicated to addressing various questions related to Remote and Digital Access Provision. About Expert Group I - Researcher experiences with Remote/Virtual Access (organised by INTERACT Non-Profit Association, INPA)

Quality assurance covers the whole chain of access provision, including the processes for user selection and guidance, training of staff, methods and platforms used in access provision, sample handling and sharing of results, and the collection and analysis of user feedback on remote and virtual/digital access services to RIs.

The expert group, consisting of members across domains, service categories and geographical regions, will focus on successful solutions and current challenges in the quality assurance of remote and virtual/digital access services, as experienced both by the access providers and the researchers using the services. Future developments in quality



assurance will also be explored, leading to improved processes in remote and digital access service provision, and ultimately, to improved user experience.

The expert group will have 2-3 on-line meetings in 2023. The results will be compiled into actionable recommendations on quality assurance of remote and digital access services, feeding into a Green Paper on transition to remote access to RIs.
